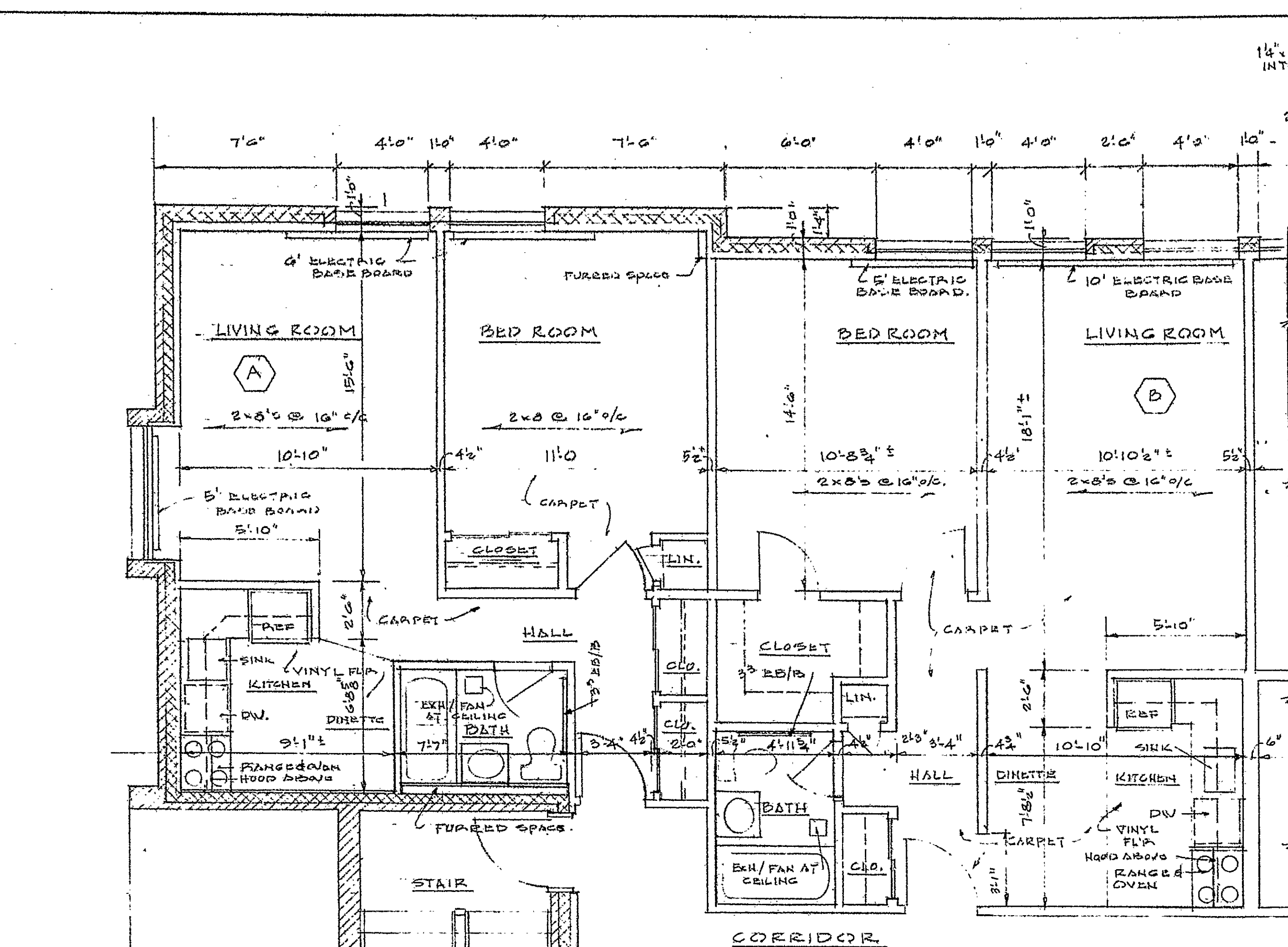
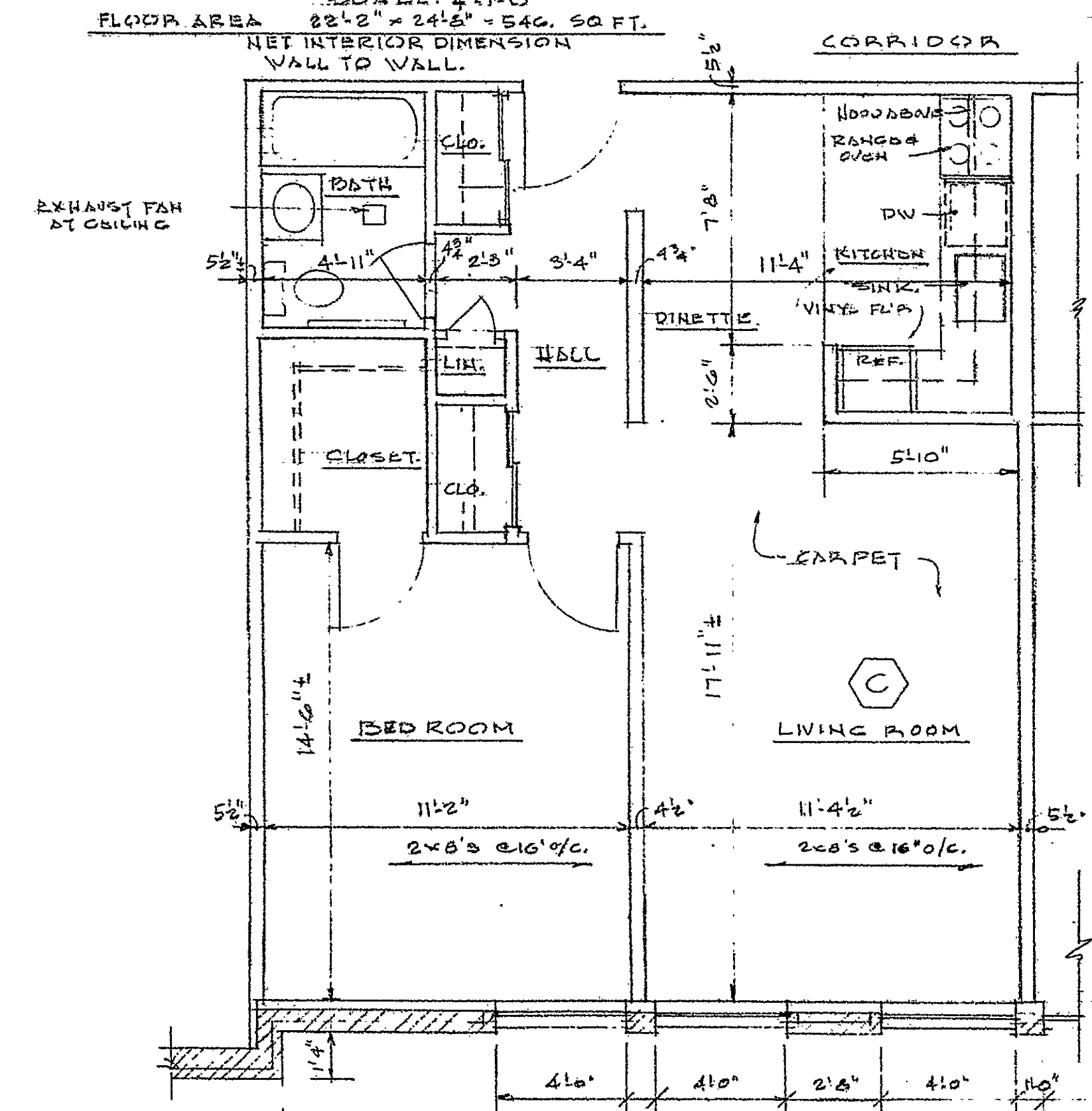
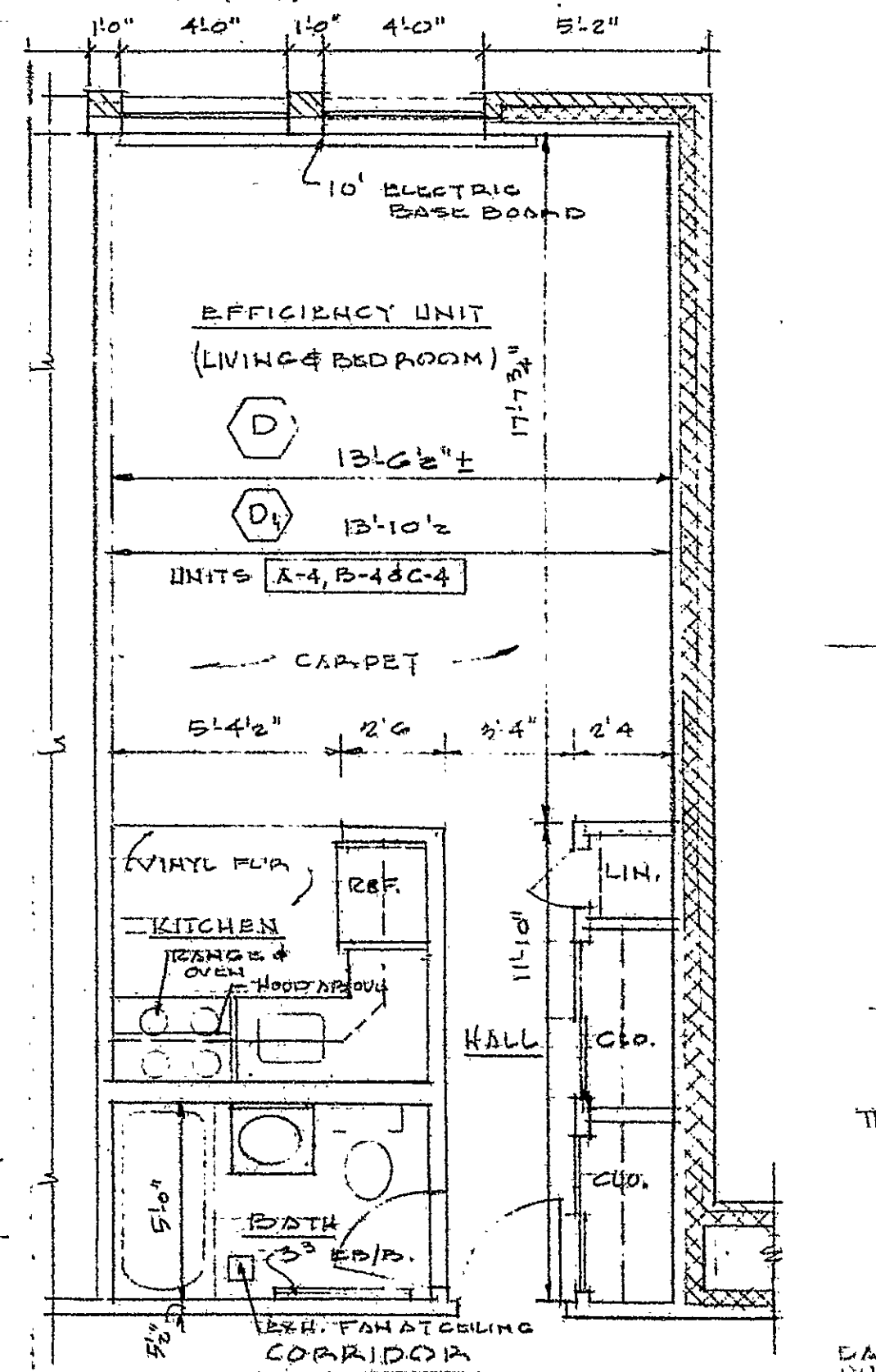




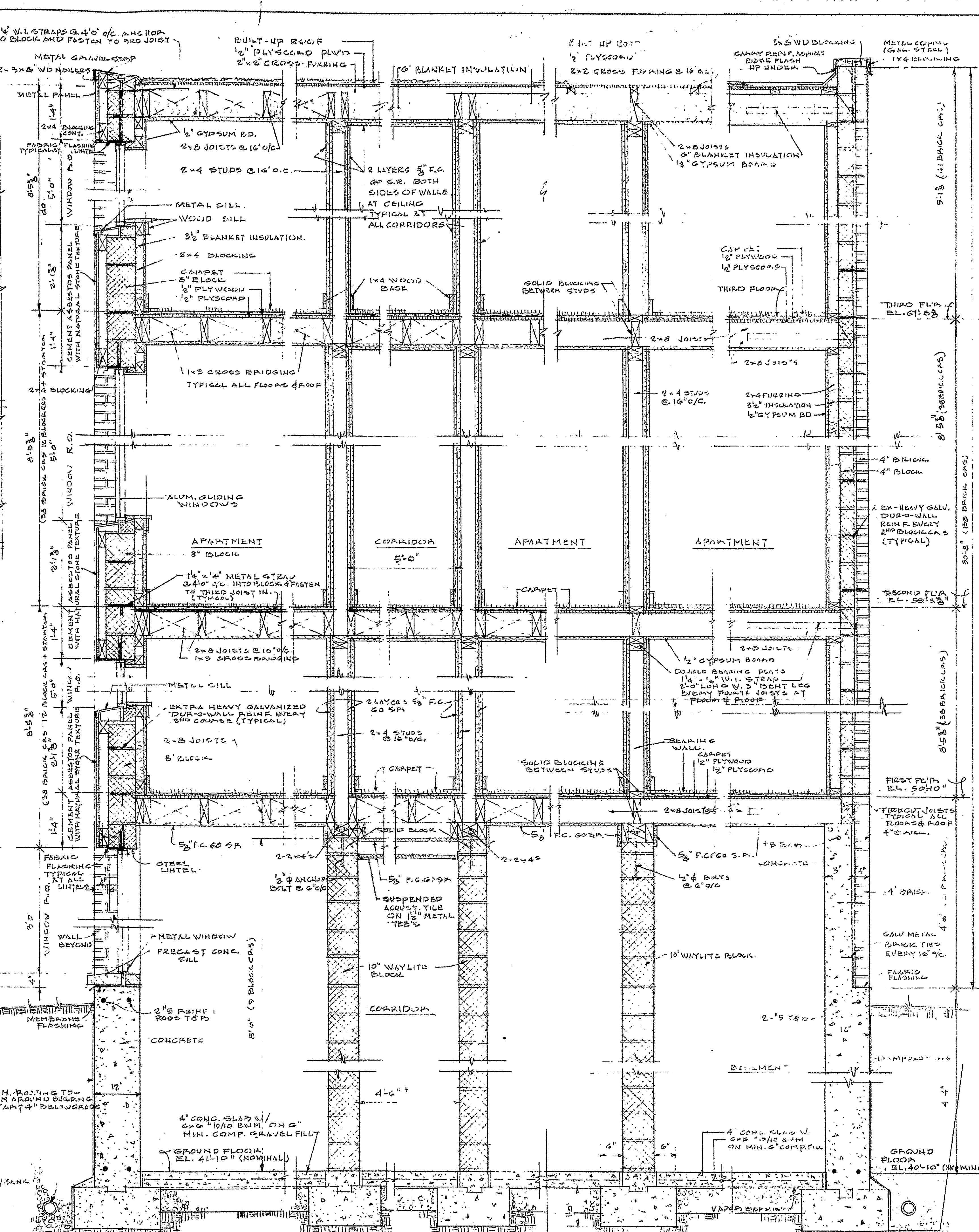
TYPICAL ONE BED ROOM APARTMENT TYPE (A)
