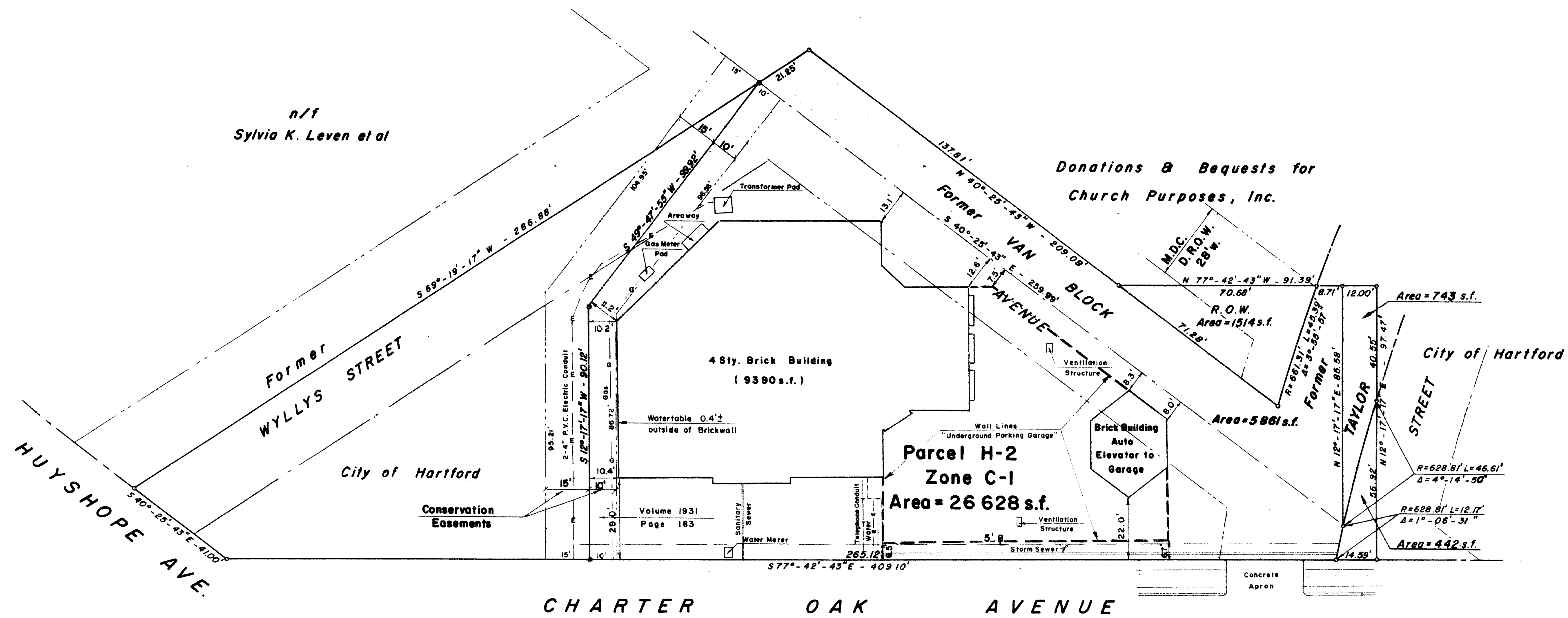

GENERAL NOTES:

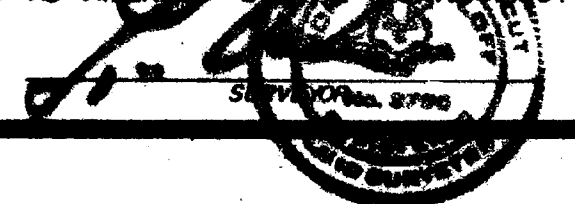
1. Former Van Block Avenue and former Taylor Street are subject to possible Utility Easements.
