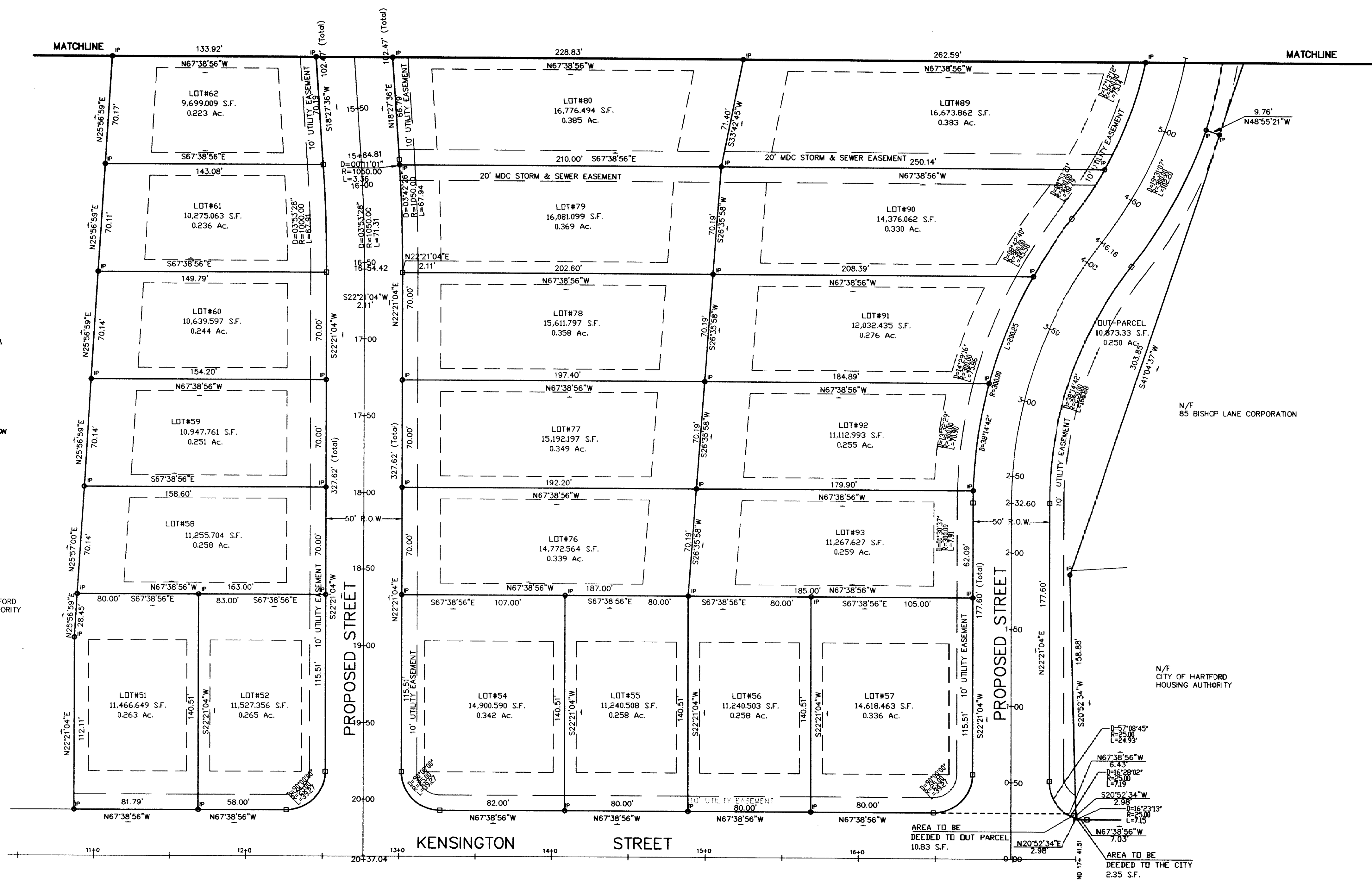

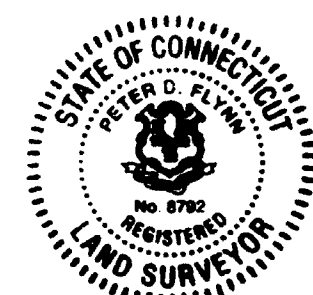

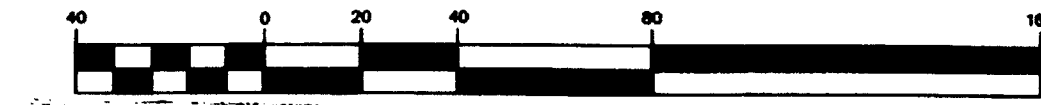
THE PORTIONS OF KENSINGTON AND
