THIS SURVEY HAS BEEN PREPARED PURSUANT TO THE MINIMUM STANDARD STATE REQUIREMENTS OF A LATA/ALCSA LAND TITLE SURVEY, AND THE SURVEY IS CONNECTED TO THE PREVIOUS SURVEY, 2003-2004-2005-2006-2007 AND THE STANDARDS FOR SURVEYS AND MAPS IN THE STATE OF ALABAMA, AND THE STANDARDS FOR SURVEYS AND MAPS IN THE UNITED STATES OF AMERICA, AS ADOPTED BY THE ASSOCIATION OF LAND SURVEYORS, INC. ON SEPTEMBER 28, 1996.
